Second Five-Year (Sunset) Review and Injury Investigation into an Antidumping Duty Order on Certain Cold-rolled Stainless Steel Products from China and Korea

Background

On August 7, 2024, the Ministry of Finance (MOF), pursuant to the Regulations Governing the Implementation of the Imposition of Countervailing and Antidumping Duties (hereinafter referred to as the Regulations) and in response to a request by Yieh United Steel Corp. and Tang Eng Iron Works Co., Ltd., initiated a second sunset investigation concerning the antidumping duty order on the aforementioned case.

Following the decision by the MOF, the International Trade Administration (TITA) of the Ministry of Economic Affairs (MOEA) seeks to determine whether the expiry of the antidumping duty order would likely lead to a continuation or recurrence of injury.

In accordance with Article 44 of the Regulations, the procedure of investigating an antidumping case shall be applied mutatis mutandis to a review case. According to Article 19 and Article 44 of the Regulations, the TITA requests the known interested parties (including domestic producers, importers, purchasers and foreign producers/exporters) to respond to a questionnaire.

- 1. Product concerned: Certain Cold-Rolled Stainless Steel Products.
- 2. Scope of Product concerned: SUS 300 series flat-rolled products of stainless steel, cold-rolled (cold-reduced), whether in coils or sheets, with thickness less than 4.75mm.
